- Welcome new member, Elizabeth Swagerty, representing Graduate Student Council
- Invitee: Rebecca Oliver, Director of the Honors College
 - Proposal: *Honors Admission Criteria for Fall 2016 Incoming Freshmen* -- to increase the Honors admission criteria.
 - This proposal is sponsored by the Honors Council and the Honors College.
 - Motion: This is not a shared governance issue (Mike McDaniel). Seconded (John Pratte). Motion carries.
- Open Issues
 - 14FA-01 Smoke-Free Campus Policy broadens the ban to include smokeless tobacco and all vaping devices.
 - <u>Status</u>: Completed. Jeff Pittman will submit SGOC's report to the Chancellor.
 - 14FA-02 Proposed PRT Procedural Changes edits to Faculty Handbook to include procedural language that ensures that pre-tenured faculty receive the annual written retention recommendations.
 - Up-and-down vote completed.
 - Discussion regarding Chairs Council vote of NO: In the final version of the proposal, an extra sentence was struck that shouldn't have been – "The chair will then provide the pre—tenured faculty member with copies of these recommendations."
 - <u>Status</u>: Jeff will check with UPRTC to see if the sentence can be put back in. If yes, Jeff will prepare SGOC's report for submission to the Chancellor.
 - 14FA-03 *Revised Guidelines for the Selection of Academic Administrators* -- clarifies the processes for internal and external searches for the selection of Chairs, Deans, and Vice Chancellor and Provost.
 - Discussion: Check that the wording in the final version of the proposal for up-anddown vote uses language like "reasonable efforts will be made . . ." instead of "should." The relevant sections are II.f. (once) and II.g. (twice).
 - <u>Status</u>: Final draft from responsible committee (Faculty Handbook Committee) is being prepared; then ready for up-and-down vote.
 - 14FA-04 Proposal to add teaching credit for overseeing masters theses and Ph.D. dissertations.
 - <u>Status</u>: This not a formal proposal yet. John Pratte and/or Mike McDaniel will write and submit.
 - 14FA-05 *Proposal for Modifying Post-Tenure Review* this is a rewrite of last year's proposal, 13FA-08. Rewrite was prepared by UPRTC.
 - <u>Status</u>: In initial review stage. Constituency groups: Faculty Senate, Chair's Council, Dean's Council. Send comments to UPRTC; copy Jeff, by January 26, 2015.

- 14FA-06 *Proposal for Adding Evaluation of Administrative Duties to PRT* this is a rewrite of last year's proposal, 13FA-07. Rewrite was prepared by UPRTC.
 - <u>Status</u>: In initial review stage. Constituency groups: Faculty Senate, Chair's Council, Dean's Council. Send comments to UPRTC; copy Jeff, by January 26, 2015.
 - Clarification: The one paragraph written by UPRTC is what we are reviewing.
- Update on SGOC's role in the college reorganization
 - Two committees with different compositions (1) Provost's committee; (2) Faculty Senate Committee
 - Motion to formally invite both committees to submit their proposals/recommendations to SGOC for the shared governance process (Andy Mooneyhan). Motion seconded (Randall Tate). Motion passed.

 - Editorial change to the Faculty Handbook revise the Faculty Handbook to reflect there is no Dean of Honors College. (Mike McDaniel)
 - Proposal: Faculty Achievement Awards selection and criteria revision
 - This proposal is sponsored by the Faculty Achievement Awards Committee (FRAC)
 - Motion: This is not a shared governance issue (Julie Isaacson). Seconded (John Pratte). Motion carries.
