30 Years Ago

- 1980s Farm Crisis in the immediate backdrop
- In the last year of the 1990 Farm Bill, and about to embark on the experiment of "Freedom to Farm"
- President Bill Clinton & The Republican Revolution
- Significant and growing federal budget deficit
- Ag exports generally strong



30 Years Ago

- Ukrainian independence & the Dissolution of the Soviet Union (1991)
- Last Russian troops departed Germany (1994)
- Establishment of the North American Free Trade Agreement (NAFTA)
- World Trade Organization (WTO) created January 1, 1995
- The Agreement on Agriculture on same day
- First GM crop(s) commercially planted
- Some "checkoff" programs were recently established





- Is there still a Farm Bill, or has the last Farm Bill already been enacted?
- Is there a farm safety net, and, if so, what does it look like?
- Is there still an Agriculture Committee in the U.S. House and Senate?
- What does the crop protection industry look like?
- What tools are available to producers and under what circumstances?



- What does the crop protection industry look like?
- What crop protection/pesticide tools are available to producers and under what circumstances?
- Has on-farm usage agricultural biotechnology increased or decreased?
- What does "coexistence" look like within production agriculture?



- How did the Russian invasion of Ukraine conclude, and what was the impact of that outcome on ag trade and markets?
- Does Ukraine exist? What government controls the agricultural lands and fertilizer markets in present-day Ukraine?
- Did we have a conflict with China such that global supply chains were redrawn?



- How well did we navigate competing pressures on and rural land from ag production, urban encroachment, surface and groundwater management, and wind, natural gas, solar, and carbon?
- Did *a lot* of producers and landowners end up making any good money on carbon contracts?
- Did "cell-cultured meat" ever catch on with consumers?
- How much more (or less) prevalent is indoor agriculture?



- What is the role of foreign investors in U.S. agriculture, including ownership of private agricultural land?
- What role do states play in regulating commerce in the wake of the U.S. Supreme Court's "Proposition 12" decision?
- Is the Corporate Transparency Act still law or has it been significantly amended?
- Supreme Court impact on ag industry?



Thoughts About the Past and the Future

- Agriculture is a very, very mature industry but still dynamic enough to constantly change
- No matter what, agriculture will always be about moving dirt, water, and money
- Agriculture and the United States can't have one without the other
