• Audrey Bowser: Admissions

Dr. Bowser presented a proposal for changes to the admission procedures to the Teacher Education Program to become effective fall of 2018 if passed.

Dr. Bowser discussed a handout explaining the proposed changes.

The Admissions Committee looked at ways to satisfy CAEP requirements. They looked at The ACT and Praxis Core. It was noted that students are more likely to take ACT due to cost. Also, students will need to take the writing portion of the ACT. One major point is that recruitment needs to improve.

Also recommended doing away with the Philosophy paper requirement.
