Justification for Position

Flute has been taught at A-State by a tenure-track faculty member for decades. This instrument plays a significant role in all of our instrumental ensembles. It is also a vital part of the curriculum required for our Bachelor of Music Education Instrumental Majors. The BME Instrumental Degree has been the most popular and steadfast program in the Department of Music. It is not possible for our

department to function properly without this faculty line. Each and every BME Instrumental Major must become proficient in teaching flute through the Flute Techniques course. The absence of an Applied Flute tenure-track position would be a disservice to our students and a devastating blow to the caliber of faculty we attract. For instance, in the past two years, recruiting for the flute studio has produced one of the most talented groups of flute students we have had in decades. According to Prof. Bonner that are currently 14 music majors taking lessons from him. A lack of stability in our flute position would undoubtedly jeopardize our enrollment and recent recruiting successes. Additionally, within the last 5 years graduate students have been enrolled within our flute studio for graduate credits. The instrumental talent for which we strive in recruiting not only demands, but also is deserving of consistent, fine instruction. Without this flute position, we would surely lose students to other universities within our state and region.

To further clarify the Applied Flute teaching responsibilities, not only do they ensure instructional knowledge in woodwind instruments required of all BME Instrumental Majors, but they also secure critical ensemble members for our Wind Ensemble, Symphonic Band, Marching Band, Orchestra, Chamber Groups and other departmental ensembles. Beyond the ensemble experience/requirements, it is essential to offer superior instruction for all woodwinds as solo instruments. Fulfilling the standards for the BME Instrumental Degree requires students to perform solo literature with utmost skill. The flute is no exception. Thus, a tenure-track faculty line for Applied Flute is without question, an essential position if we are to progress as we uphold the high standard of education we have here at Arkansas State University.

Justification for Position

The athletic bands play a significant role in the life of our university. Not only are they part of the curriculum required for our Bachelor of Music Education Instrumental Majors, athletic bands also serve co-curricular and extracurricular functions at A-State. For example,

currently there are 47 different majors represented among the students in the Sound of the Natural State and students in the athletic bands often have commitments during the Fall Break at Thanksgiving and during the break between the fall and spring semesters. Additionally the athletic bands are among the most visible academic courses offered at A-State.
