Substance abuse was identified as a major health concern among state agencies in rural areas national wide. In Arkansas there is a shortage of health care professionals, including social workers, having the training to deal with substance abuse issues. The State of Arkansas predicts that there will be 617 new social work positions each year. Addressing the issues of substance abuse treatment and prevention in Arkansas begins with the education of professionals who are equipped to deal with the unique behavioral and social conditions that impact substance abuse in rural areas. There is currently no formalized program on addiction studies at ASU-J. The need for such a program exists. From July 1, 2007 through May 31, 2008, Craighead Count had 486 felony drug charges, and in 2005 Mississippi County had 315 and Clay County had 47. For Craighead County these cases involved drugs su as marijuana (142), cocaine (53), crack (119), methamphetamine (130), and pharmaceutical (42). Recruitment and retention of Black students will be pursued. - #16—How will the program be assessed?
  - 1) Graduating with this certificate alone does not make the student eligible for any of the credentials offered by the State Board of Examiners of Alcoholism and Drug Abuse Counseling. Those categories include Licensed Alcoholism and Drug Abuse Counselor, Certified Alcoholism and Drug Abuse Associate and Certified Alcoholism and Drug Abuse Technician. The legislative language and the licensure submission checklist are included as an FYI (minimum 270 clock hours of approved education and 6000 hrs of supervised experience). This certificate does constitute at minimum168 hours of approved education and 360 hours of supervised experience toward any one of the licensure categories listed above. Licensure tracking is not an appropriate mechanism for this graduate certificate.
  - Course evaluation and faculty evaluations will occur on courses in this certificate option.
  - 3) A comprehensive written assessment will occur at the completion of the certificate to assess didactic and clinical knowledge in the addictions arena. This assessment will be built into SW 5293: Practicum in Addiction studies for Track B and SW 6813: Full Time Advanced Field II for Track A.
  - 4) An exit survey will be completed with those finishing the certificate to ascertain information on course sequencing and other aspects of the certificate program not readily assessed through course and faculty evaluations.

(a) certificates of workshops, in-service trainings, and/or conferences (minimum of six hours related to ethics); <u>AND/OR</u>

(b) overview and documentation of continuing education related to theory, practice, or research from an accredited institution of higher education (3 semester hours converts to 42 clock hours of approved education)

(c) copy of current certification from the Arkansas Substance Abuse Certification Board, if applicable

# All education hours are subject to review and approval by the SBEADAC Credentialing Committee.

## Act 1588 of 1999 Senate Bill 254

## "AN ACT TO PROVIDE FOR THE LICENSURE AND REGISTRATION OF ALCOHOLISM AND DRUG ABUSE COUNSELORS; AND FOR OTHER PURPOSES."

#### SUBTITLE – "TO PROVIDE FOR THE LICENSURE AND REGISTRATION OF ALCOHOLISM AND DRUG ABUSE COUNSELORS." BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

#### SECTION 1. Definitions. As used in this act:

- (1) "Board" means the State Board of Examiners of Alcoholism and Drug Abuse Counselors created by this Act;
- (2) "Certified clinical supervisor" means a person certified by the Arkansas Substance Abuse Certification Board or the State Board of Examiners of Alcoholism and Drug Abuse Counselors to provide clinical supervision for applicants for certification or licensure;
- (3) "Licensed alcoholism and drug abuse counselor" means a person who renders, for compensation, alcoholism and drug abuse counseling or alcoholism and drug abuse counseling-related services to an individual, group, organization, corporation, institution, or to the general public, and who holds a license issued by the State Board of Examiners of Alcoholism and Drug Abuse Counselors, or by another health or behavioral sciences board to engage in the practice of alcoholism and drug abuse counseling;
- (4) "Practice of alcoholism and drug abuse counseling" means the professional activity of helping individuals, groups, organization, corporations, institutions, or the general public, to develop an understanding of alcoholism and drug dependency problems; and defining goals and planning action reflecting the individual's or group's interest, abilities and needs as affected by claimed alcoholism and drug dependency problems. It includes the professional application of values, principles and techniques to one or more of the following ends: counseling with individuals, families and groups; helping people obtain tangible services; assisting communities or groups; providing or improving social and health services; and engaging in alcoholism and drug abuse education and prevention through the appropriate administration of alcoholism and drug abuse counseling services; and
- (5) "Supervised work experience" means paid or voluntary work experience as an alcohol and drug abuse counselor who provides alcohol and drug abuse services, under the supervision of a credentialed alcohol and drug abuse counselor, to persons with alcoholism or other drug dependency or both.

#### **SECTION 2.** Purpose.

- (a) It is the purpose and policy of the State of Arkansas to protect the public form being misled by incompetent and unauthorized persons and from unprofessional conduct on the part of qualified alcoholism and drug abuse counselors by providing regulatory authority over persons who hold themselves out to the public as licensed alcoholism and drug abuse counselors under this Act.
- (b) The purpose of the act is to allow the State Board of Examiners of Alcoholism and Drug Abuse Counselors to establish appropriate licensure and certification requirements and define the practice of alcoholism and drug abuse counseling and to promote high standards of professional performance for those engaged in the practice of alcoholism and drug abuse counseling by setting standards of qualification, training and experience for those who seek to engage in the practice of alcoholism and drug abuse counseling under the Act.

- (3) Four (4) of the initial members shall be alcoholism and drug abuse counselors certified by the Arkansas Substance Abuse Certification Board who are licensed under the provisions of this act and who engage in the independent practice of alcoholism and drug abuse counseling. Their successors shall be alcoholism and drug abuse counselors licensed by the State Board of Examiners of Alcoholism and Drug Abuse Counselors who have rendered service, education or research I alcoholism and drug abuse counseling for at least five (5) years.
- (4) One (1) member shall be licensed by an Arkansas health or behavioral sciences board and hold a specialty in alcohol and drug abuse counseling or addiction and a current license from their licensing boards.
- (5) One (1) member who is a licensed professional counselor with a specialty in alcohol and drug counseling or addiction.
- (6) One (1) member shall be a citizen at large who is not associated with or financially interested in the practice or business regulated.
- (b) The initial members of the board shall be appointed so that three (3) serve a one-year term; three (3) serve a two-year term; three (3) serve a three-year term; and four (4) serve a fouryear term. Successor members shall serve four-year terms except that persons appointed to fill vacancies resulting in an unexpired term shall serve for the remainder of that unexpired term.
- (c) Upon recommendation of the board, made after notice and hearing, the Governor may remove any member of the board for incompetence, neglect of duty or malfeasance in office.
- (d) Any vacancy on the board shall be filled by the Governor.
- (e) The Governor shall call the first board meeting and designate a member to preside at that meeting. The board shall elect annually from its membership a chairperson, vice-chairperson and a secretary. The board shall meet as frequently as it deems necessary, at such times and places as the board designates. Additional meetings may be held upon call of the chairperson or upon written request of five (5) members of the board.
- (f) Seven (7) members of the board shall constitute a quorum.

#### SECTION 5. Compensation for board members.

The members of the board may receive a stipend of sixty dollars (\$60.00) per day for each day of attendance at a board meeting plus expense reimbursement pursuant to Arkansas Code25-16-901 through 908. Stipend and expense reimbursement shall not be made if available funds are insufficient for this purpose.

#### SECTION 6. Powers and duties of board.

- (a) The board shall administer and enforce the provisions of this act and shall adopt rules and regulations consistent with its provisions, including a code of ethical practice.
- (b) The board shall review and act upon application for licensure and certification at least four(4) times a year and shall regulate the renewal of licenses or certifications.
- (c) The board may conduct hearings on charges calling for the denial, revocation or suspension of a license or certification, shall adopt rules for the conduct of the hearings, and shall cause the prosecution of all persons who violate any provisions of this act or any rule or regulation promulgated pursuant to its provisions.
- (d) The board may sue and be sued in its own name.
- (e) The board may employ any persons it deems necessary to carry on the work of the board and shall define their duties and fix their compensation within the limits prescribed by law.
- (f) The board shall maintain a register of all individuals licensed or certified under the provisions of this Act. The register shall be a public record.

- (g) The board shall keep a complete record of all of its proceedings.
- (h) The board shall set by regulation a fee schedule for examination. The fees shall be set at a level sufficient to cover the cost of preparations, administration and grading of the examination.

#### SECTION 7. Board to enjoin violations.

When it appears to the board that a person is violating any provisions of this act, the board or any member thereof shall not be required to furnish bond for any cost or filing fees in connection with the proceeding.

#### SECTION 8. License, alcoholism and drug abuse counselor - requirements for issuance.

- (a) The board shall issue the license as 'licensed alcoholism and drug abuse counselor' to an applicant who meets the following requirement:
  - (1) Is at least twenty-one (21) years of age;
  - (2) Has successfully completed a minimum of three (3) years or six thousand (6,000) hours of supervised experience. Supervised experience must be approved and documented by a Certified Clinical Supervisor in good standing with the board;
  - (3) Has successfully completed a minimum of two hundred seventy (270) clock hours of approved education. Approved education must be directly related to alcoholism and/or drug abuse counseling subjects, theory, practice or research;
  - (4) Has submitted an application on a form provided by the board;
  - (5) Has certified under penalty of perjury as evidence by a notarized signature on the application for licensure, that all education and experience requirements have been met;
  - (6) Has submitted three (3) letters of reference;
  - (7) Has paid to the board an examination fee, fixed by the board;
  - (8) Has passed a national qualifying written examination and oral examination prescribed by the board, sufficient to ensure professional competence in keeping with the highest standards of the alcoholism and drug abuse counseling profession;
  - (9) Has signed a written agreement to abide by the code of ethics adopted by the board; and
  - (10) Holds a masters degree is the health or behavioral sciences field or other appropriate field from an accredited college or university.
- (b) The license shall be displayed in the licensee's principal place of practice and shall entitle the licensee to hold himself forth to the public as providing services as authorized by this act.

#### SECTION 9. Certified, alcoholism and drug abuse associate - requirements for issuance.

- (a) The board shall issue the certification as 'certified alcoholism and drug abuse associate' to an applicant who meets the following requirements:
  - (1) Is at least twenty-one (21) years of age;
  - (2) Has successfully completed a minimum of three (3) years of six thousand (6,000) hours of supervised experience. Supervised experience must be approved and documented by a Certified Clinical Supervisor in good standing with the board;
  - (3) Has successfully completed a minimum of two hundred seventy (270) clock hours of approved education. Approved education must be directly related to alcoholism and/or drug abuse counseling subjects, theory, practice or research;
  - (4) Has submitted an application on a form provided by the board;
  - (5) Has certified under penalty of perjury as evidence by a notarized signature on the application for licensure, that all education and experience requirements have been met;
  - (6) Has submitted three (3) letters of reference;
  - (7) Has paid to the board an examination fee, fixed by the board;

- (8) Has passed a national qualifying written examination and oral examination prescribed by the board, sufficient to ensure professional competence in keeping with the highest standards of the alcoholism and drug abuse counseling profession;
- (9) Has signed a written agreement to abide by the code of ethics adopted by the board; and
- (10) Holds a baccalaureate degree in the health or behavioral sciences field or other appropriate field from an accredited college or university.
- (11) Successful completion of a minimum of two hundred seventy (270) additional clock hours of board approved training;
- (12) Successful completion of a minimum of two (2) years or two thousand (2,000) hours of supervised direct counseling experience in the alcoholism or drug abuse counseling field, either paid or voluntary. For national reciprocity, a minimum of four thousand (4,000) hours is required. Supervised experience must be approved and documented by a Certified Clinical Supervisor in good standing with the board;
- (13) Successful completion of a minimum of three hundred (300) hours of supervised direct counseling practicum. Supervised experience must be approved and documented by a Certified Clinical Supervisor in good standing with the board. This practicum may be included in place of the above-mentioned requirement of two (2) years experience; and
- (14) Successful completion of the written examination and oral examination for the certification as a certified alcoholism and drug abuse associate.
- (b) The certification shall be displayed in the associate's principal place of practice and shall entitle the individual to hold himself forth to the public as providing services as authorized by the act.
- (c) Associates certified by the board may engage in the practice of alcoholism and drug abuse counseling only while under the direct supervision of a licensed alcoholism and drug abuse counselor or other health professional licensed under other behavioral sciences or health boards and practicing alcoholism and drug abuse counseling.

# SECTION 10. Certified, alcoholism and drug abuse technician – requirements for issuance.

- (a) The board shall issue the certification as "certified alcoholism and drug abuse technician" to an applicant who meets the following requirements:
  - (1) Is at least twenty-one (21) years of age;
  - (2) Has successfully completed a minimum of three (3) years or six thousand (6,000) hours of supervised experience. Supervised experience must be approved and documented by a Certified Clinical Supervisor in good standing with the board;
  - (3) Has successfully completed a minimum of two hundred seventy (270) clock hours of approved education. Approved education must be directly related to alcoholism and/or drug abuse counseling subjects, theory, practice or research;
  - (4) Has submitted an application on a form provided by the board;
  - (5) Has certified under penalty of perjury as evidence by a notarized signature on the application for licensure, that all education and experience requirements have been met;
  - (6) Has submitted three (3) letters of reference;
  - (7) Has paid to the board an examination fee, fixed by the board;
    (8) Has passed a national qualifying written examination and oral examination prescribed by the board, sufficient to ensure professional competence in keeping with the highest standards of the alcoholism and drug abuse counseling profession;
  - (9) Has signed a written agreement to abide by the code of ethics adopted by the board; and
  - (10)Holds a high school diploma or equivalent.

- (b) The certification shall be displayed in the associate's principal place of practice and shall entitle the individual to hold himself forth to the public as providing services as authorized by this act.
- (c) Technicians certified by this board may engage in the practice of alcoholism and drug counseling only while under the direct supervision of a licensed alcoholism and drug abuse counselor other health professional licensed under other behavioral sciences or health boards and practicing alcohol and drug counseling.
- (d) The technicians shall not receive a license as a licensed alcoholism and drug abuse counselor or a certificate as a certified alcohol and drug abuse associate unless the provisions of sections 8 and 9 of this Act have been met.

## **SECTION 11. Certified Clinical Supervisors.**

The board may issue certificates to persons who meet the qualifications and standards established by the board for Certified Clinical Supervisors.

#### SECTION 12. Grandfather clause.

- (a) The board shall issue the appropriate license or certificate to any person who holds a current valid certification from the Arkansas Substance Abuse Certification Board as a Certified Substance Abuse Counselor or other such persons holding a valid license under other health or behavioral science boards and practicing alcoholism and drug abuse counseling and who:
  - (1) Is in good standing with the board;
  - (2) Has submitted an application to the board on a form provided by the board;
  - (3) Has paid to the board an application fee; and
  - (4) Has signed a written agreement to abide by the code of ethics adopted by the board.
- (b) No person shall be grandfathered under the provisions of this section unless that person has the required educational qualifications as required by this Act.

#### SECTION 13. License and certificate renewal - Fee - Waiver.

- (a) Each licensed alcoholism and drug abuse counselor, certified alcoholism and drug abuse associate and certified alcoholism and drug abuse technician shall renew his license or certificate every two (2) years and shall pay the board a renewal fee fixed by the board.
- (b) Renewal fees shall be waived for any licensee or person certified actually serving in the armed forces of the United States. The waiver shall be effective for six (6) months following honorable discharge, separation or release from the armed forces, after which period a license or certificate shall be considered lapsed.
- (c) The board may, at its discretion, require continuing education as a condition of license or certificate renewal.

# SECTION 14. Grievance procedure – Denial, revocation or suspension of license or certificate – Appeals.

- (a) The board may hear grievances of any person whose application for a license or certificate has been denied.
- (b) The board may deny, revoke or suspend any license or certificate upon proof that the person has willfully or repeatedly violated any of the provisions of this act or any rule or regulation promulgated by the board or upon proof that a person has practiced outside of the scope of practice for which they are licensed or certified under this Act.
- (c) The board shall not suspend, revoke or refuse to renew a license or certificate except after a hearing before the board upon notice to the person charged.

- (d) The notice shall be in writing, shall state the nature of the charges, the time and place of the hearing and shall be served on the person charged by certified mail not less than thirty (30) days prior to the date of the hearing.
- (e) The person charged may appear in person or by counsel, may testify and may produce evidence and witnesses on his own behalf, may cross-examine witnesses, and shall be entitled, on application to the board, to the issuance of subpoenas to compel the attendance of witnesses and the production of documentary evidence.
- (f) The board, or its authorized representative on his behalf, shall have authority to issue subpoenas to compel the attendance of witnesses and the production of documents and may administer oaths. The board may invoke the aid of the circuit court for the county in which the hearing is held to enforce compliance with its subpoenas.
- (g) A stenographic or mechanical record of the hearing shall be taken, and a transcript shall be preserved by the board.
- (h) At all hearings before the board, the Attorney General of the State of Arkansas, or one of his assistants designated by him, shall appear and represent the board.
- (i) The decision of the board shall be by majority vote thereof.
- (j) A copy of the board's order shall be sent by certified mail to the person charged at last known address.
- (k) The board may grant a rehearing when new and material evidence is offered for its consideration.
- (1) Any person aggrieved by a final order of the board may, within thirty (30) days of the entry of the order, appeal to the circuit court of the county in which he resides. The appeal shall be determined by the court upon the certified record and no new or additional evidence shall be heard or considered by the court.

# SECTION 15. All monies received by the board under this act shall be deposited in one or more financial institutions in this state. The monies shall be used for the operation of the board.

#### SECTION 16. Confidentiality of information - Exception.

No individual licensed or certified under the provisions of this Act may disclose any information he may have acquired from persons consulting him in his capacity as a person regulated under this Act, except:

- (1) With the written consent of the person or, in the case of death or disability, of his authorized representative, or the beneficiary of an insurance policy on his life, health, or physical condition;
- (2) A communication that reveals the contemplation of a crime or a harmful act;
- (3) When the communication indicates that the person was the victim of a crime, the individual shall be required to testify fully when properly ordered by a court of competent jurisdiction in any examination, trial or other proceeding in which the commission of a crime is the subject of the inquiry;
- (4) Communications made in the course of an examination ordered by a court of competent jurisdiction when the client has been informed before the examination that any communications made during the examination would not be privileged;
- (5) When the individual is a defendant in either a civil or criminal action;
- (6) If the individual has reasonable ground to suspect that a child has been abused or neglected, he shall report such information as required by law.

7

SECTION 17. All provisions of this act of a general and permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision Commission shall incorporate the same in the Code.

SECTION 18. If any provision of this act or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions of applications of the act which can be given effect without the invalid provision or application, and to this end the provisions of this act are declared to be servable.

SECTION 19. All laws and parts of laws in conflict with this act are hereby repealed.
