

## DISASTER PREPAREDNESS AND EMERGENCY MANAGEMENT \_

### ■ MASTER OF SCIENCE IN DISASTER PREPAREDNESS AND EMERGENCY MANAGEMENT

The Master of Science degree in disaster preparedness and emergency management is an interdisciplinary program that prepares professionals to effectively meet the demands of disaster preparedness, mitigation, planning, response and recovery. The program requires 36 hours of graduate level courses.

#### ADMISSION REQUIREMENTS

Students interested in pursuing a Master of Science in DPEM must have a Bachelor's degree in any discipline. Applicants must meet the basic admission requirements of the Graduate School. Prospective students should apply online, pay the required application fee, and submit an official transcript of all of their undergraduate and graduate course work to the Graduate School. Applicants must schedule a personal interview with a MS DPEM advisor. Venues for the interview include face-toface, telephone, or electronic. During this interview, the adviser will outline in detail the requirements of the MS program. The adviser and the student will analyze the appropriateness of the degree given the student's goals and career objectives, the degree's requirements along with the student's academic progress to date. Admission to this degree program is conditioned upon completion of prerequisite course(s) required and acceptance by clinical agencies for practicum experiences.

#### MASTER CURRICULUM

The program consists of 36 Credit Hours that includes six Core Courses, three Emphasis Courses, a Practicum Experience, and a Final Project. The six Core Courses are each worth three credit hours (18 total) and the three Emphasis Courses are each worth three credit hours (9 total).

The Practicum Experience is worth three credit hours and students can choose between a Seminar Topics Course or a 60 hour practicum at an approved site. The Final Project is worth six credit hours to be taken in two separate three hour terms. Students may choose between competing a Research Project, a Thesis, or a 240 hour internship at an approved site.
