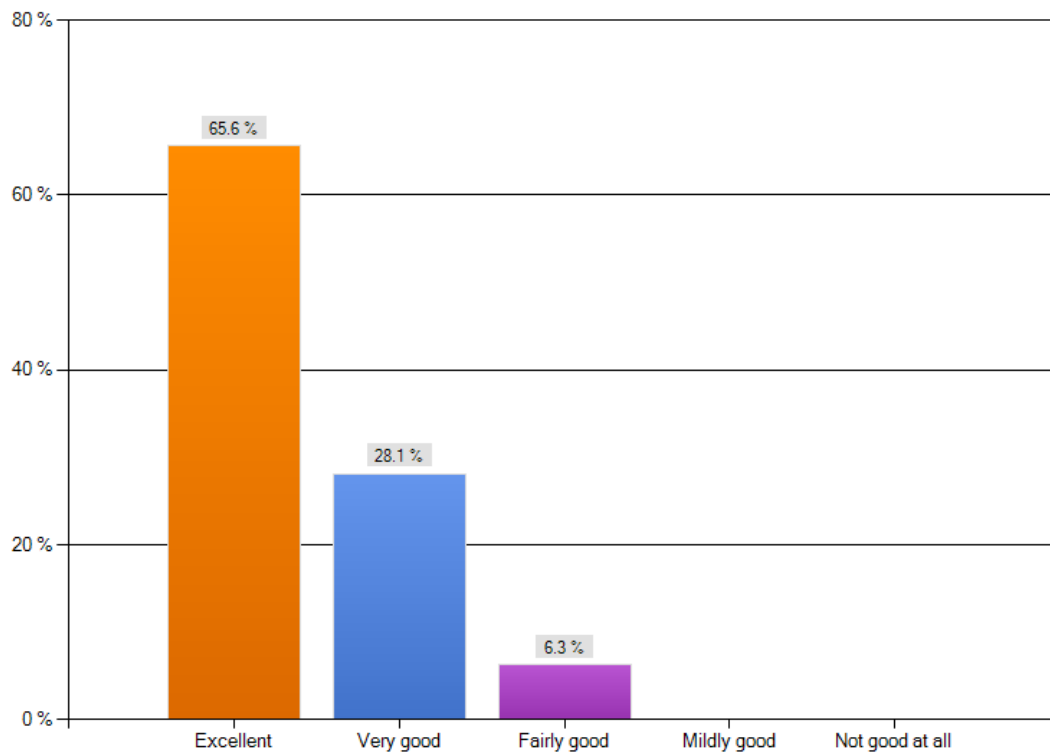
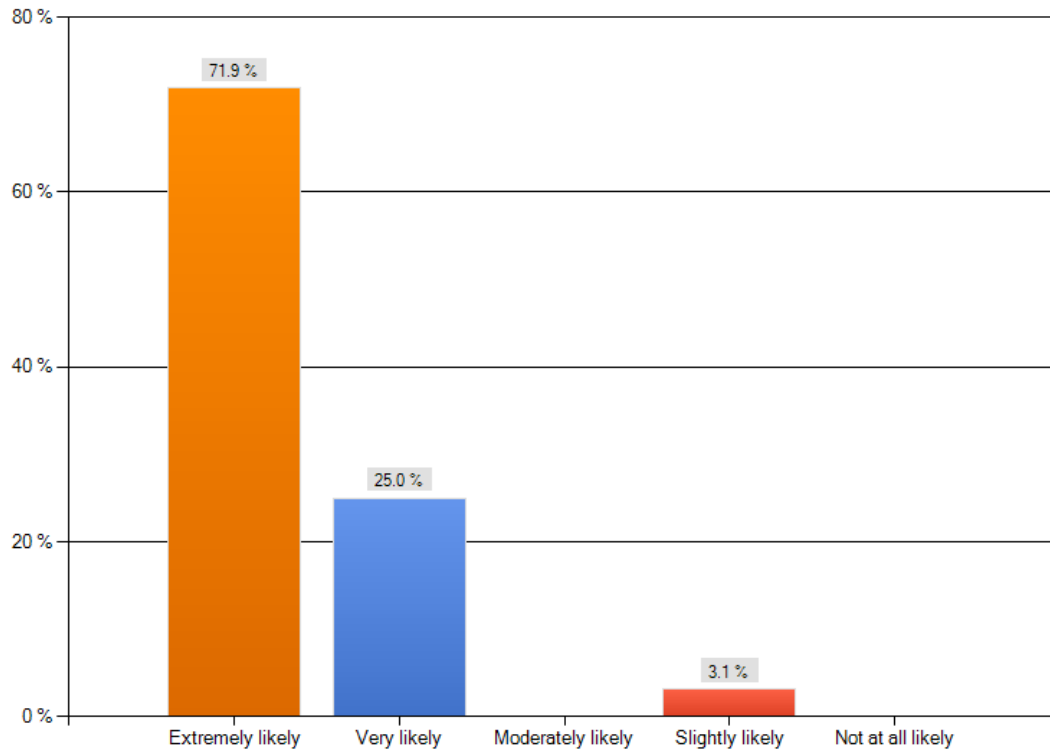


# Northeast Arkansas Section 504 Conference 2013 Survey Responses

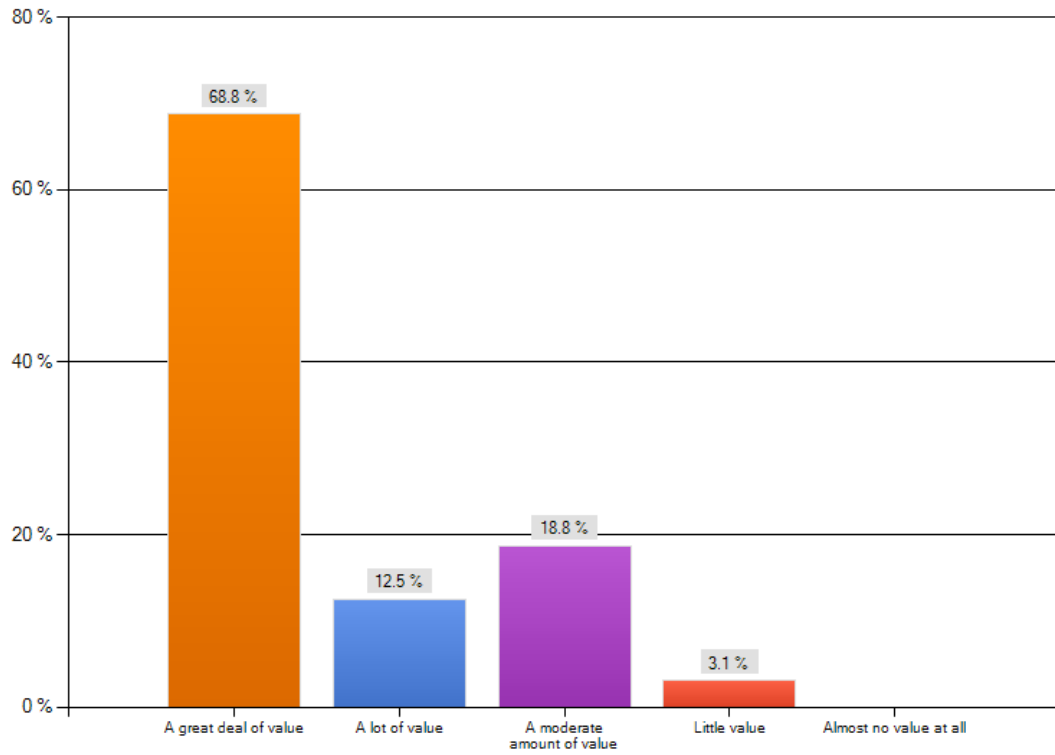

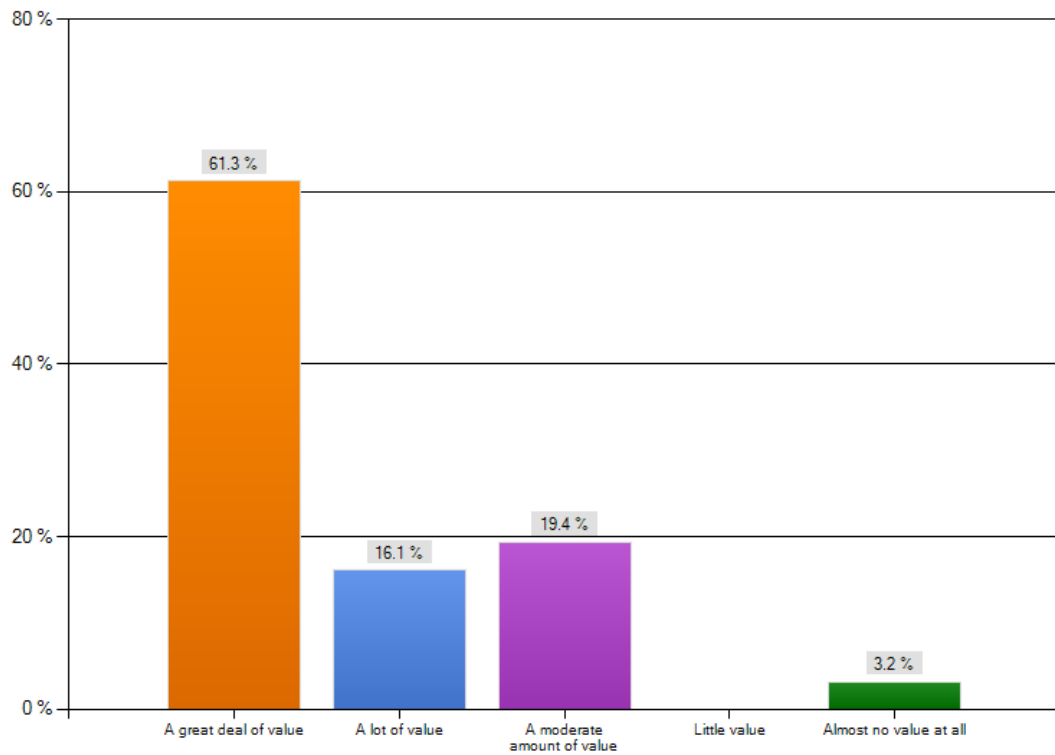

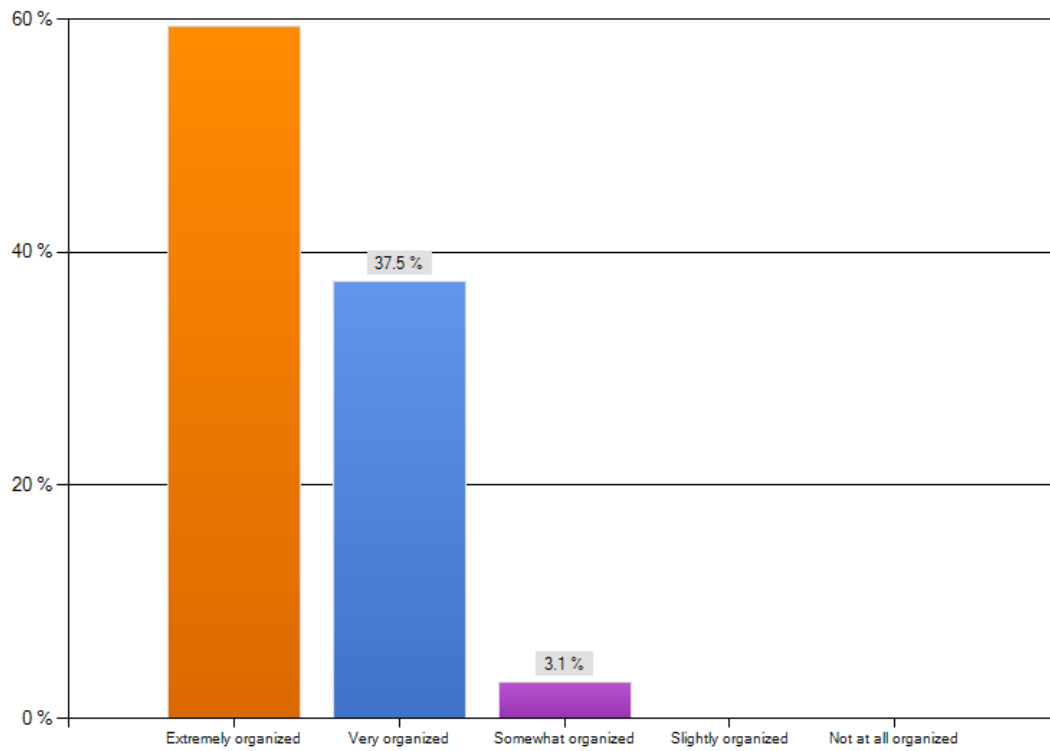
How much value for the time that you lost on the job was the event?



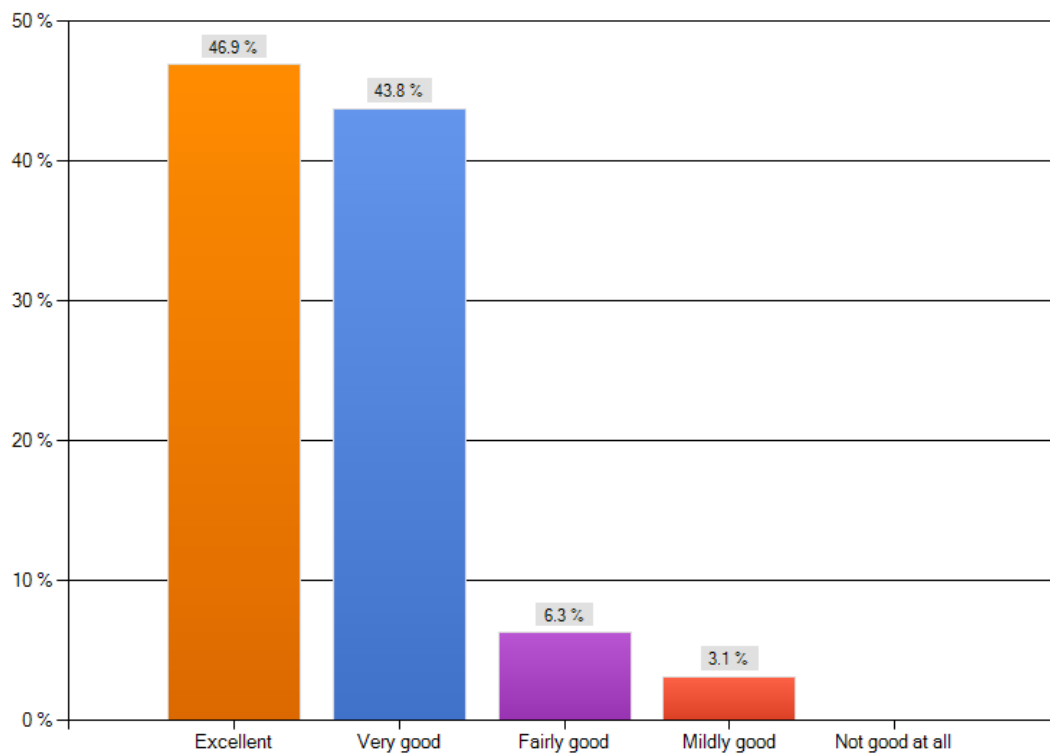
How much value for the time that you lost on the job was the event?



**How organized was the event?**

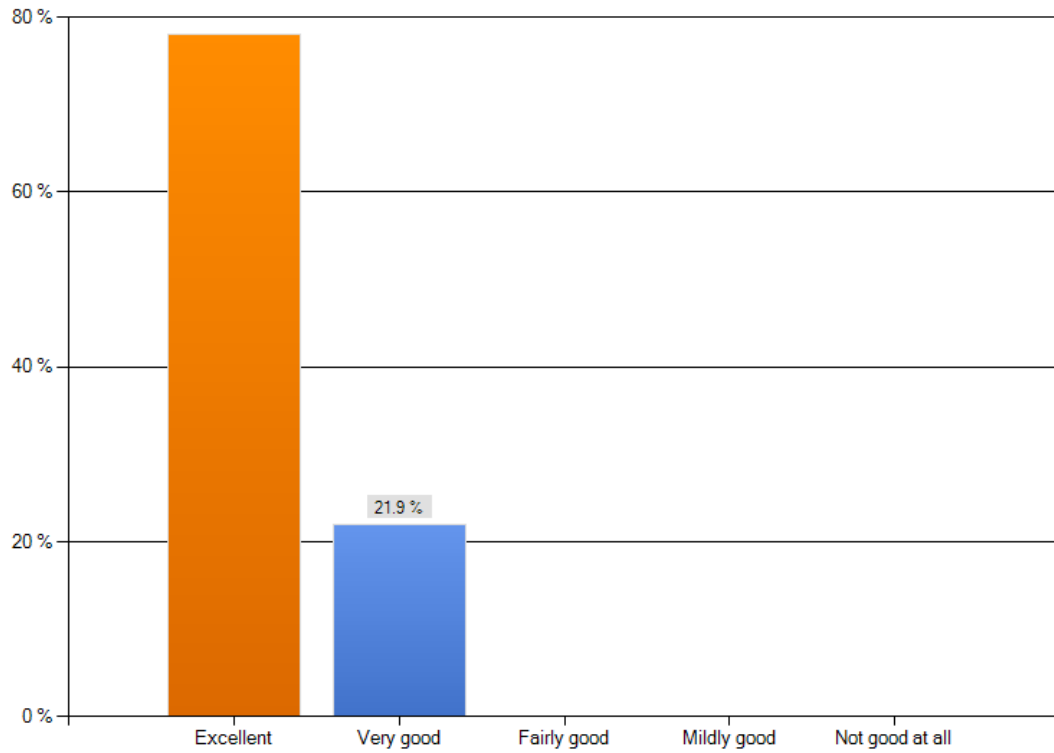


**How would you rate the food service of the event?**

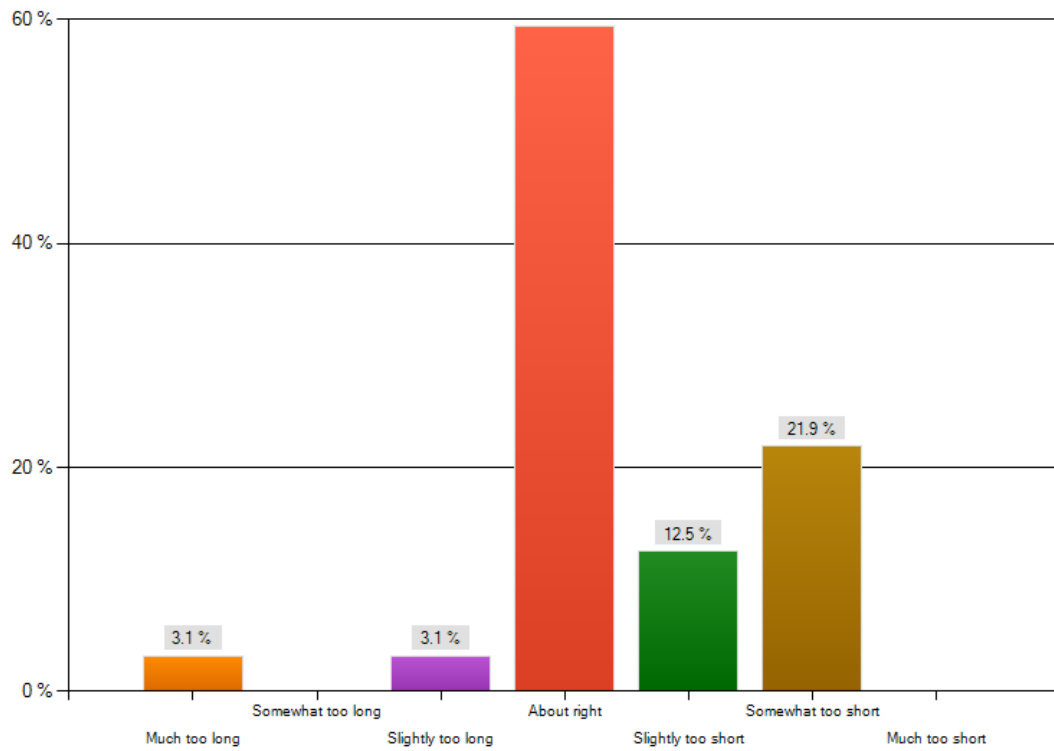




### How would you rate the parking at this event?
