Subject: Shared Governance Proposal - 15 FA 02 – Academic Hearing Committee Changes



This fall, the ASU Faculty Handbook Committee proposed changes in the ASU Faculty Handbook regarding the composition of the Academic Hearing Committee. Under shared governance, this proposal was forwarded from the SGOC to the ASU Faculty Senate, Deans Council, and Chairs Council. After comments, the Faculty Handbook Committee reported back to the SGOC that all constituency groups involved supported the proposal. The Faculty Handbook Committee believes the universal support removes the necessity for a second round of review and comment, and asks the SGOC to forward this proposal to you as presented below. The SGOC sends this proposal to you for your consideration.

- I. Date: August 31, 2015
- II. **Sponsoring Constituent**: The proposed changes come from Mike McDaniel, the Faculty Handbook Committee.
- III. **Statement of the Issue**: The current composition of the academic hearing committee includes non-tenured faculty, placing these individuals in a position of conflict of interest.

IV. Rational for the Proposal: The purpose of this proposal is to change language concerning the Academic Hearing Committee composition by removing the designation tenure-track. The proposal will make the language consistent with Section I.c.5 of the Faculty Handbook, and provide for better university governance.

The following is a comparison between the current ASU Faculty Handbook language, page 91, and the proposed language. Each subcommittee will elect one of its members to prepare a record of the proceedings and deliberations and prepare a formal report of the committee findings. The Chancellor will select a replacement from the AHC for any member of a subcommittee who must recuse him/herself or who will not be available for the duration of the hearing.
