I understand that if I am not able to meet the conditions outlined in the Agreement to Serve, the TEACH Grant will convert to a Federal Direct Unsubsidized Loan, and interest will be added to the principle from the disbursement date of the TEACH Grant, which I am responsible for repaying.

I understand that if I have already been awarded up to my cost of attendance, receiving the TEACH grant will result in the reduction of my federal subsidized, unsubsidized loan, and/or PLUS loan award.

I further understand that in order to prevent the TEACH Grant from becoming a Federal Direct Unsubsidized loan upon completion or withdrawal from the program for which the TEACH Grant was received, I must:

Serve as a full-time teacher for a least four academic years within eight calendar years in the subject area for which the TEACH Grant was received; and

Teach at a school that is designated to be a low-income school based on the Teacher Cancellation Low Income Directory.
