# Doctorate in Educational Leadership



Using an online video delivery method Arkansas State University offers a unique, quality doctoral program that is designed to meet the needs of full-time working professionals. Courses are taught online using synchronous and asynchronous formats saving students the time and expense of traveling to campus. Students participate at specific times in a video conference with the professor and fellow cohort members. Students only come to campus to attend a three-day face-toface integrative seminar during summers at the beginning, middle, and conclusion of their doctoral core courses.

### Cohort Schedule 2017:

Students will attend a three-day (3-day) integrative seminar and orientation on the A-State campus in Jonesboro during the summer before beginning their first 8000-level EdD courses in the fall and another seminar class on campus the following summer. A third seminar class will be held following completion of the core courses. The seminar and orientation classes will begin the second Saturday following the 4<sup>th</sup> of July. If the 4<sup>th</sup> of July falls on a Saturday the seminar would begin on July 18.

During the fall and spring semesters students will meet via a video conference every Wednesday, subject to the professor's discretion, beginning at 4:00 p.m. CST for the first class and at 6:30 p.m. CST for the second class. During the 5-week summer term students will meet synchronously Monday through Thursday beginning at 4:00 p.m. CST for the first class and at 6:30 p.m. CST for the second class. Online attendance is required.

## ADMISSION REQUIREMENTS

Admission is competitive and limited to a select number of cohort members each year. All students who apply to the Center for Excellence in Education for the Doctor of Education degree are screened for admission. The screening process consists of an evaluation of each student in terms of selected criteria for admission listed below. Each criterion will be assigned a numerical value.

- 1. Writing Skills,
- 2. Graduate Record Examination:
  - (GRE scores—Verbal, Quantitative, and Analytical Writing. The scores must be obtained within 5 years of date of application.),



- 3. Scholarship (Graduate Level),
- 4. Speaking Skills (interview with committee),
- 5. Recommendations, one from a direct supervisor; two from former professors,
- 6. Teaching license.

Uniform evaluation sheets are utilized by an appointed screening committee. Upon completion of the screening process the departmental committee will make a recommendation to the Graduate Program.

#### **COURSE PREREQUISITE REQUIREMENTS for ADMISSION**

To be admitted to a Doctoral cohort the student must have a teaching license and a minimum of 48 graduate semester hours inclusive of a Master's degree and must have completed a minimum of eleven (11) of the following courses (or equivalent) in addition to meeting other admission requirements:

#### **Upon Acceptance**

After acceptance into the program, the successful applicant is required to pay a \$500 non-refundable deposit to reserve a place in the designated cohort. Students who do not respond by the stipulated date will have their positions assigned to other applicants. Upon student's completion of their first fall semester of the program, the deposit will be applied to the student's tuition payment the following spring semester. Forfeited fees will revert to the Center for Excellence in Education and be used to support graduate student activities such as expenses related to the presentation of a scholarly paper, publication costs, or in support of research projects germane to the field of educational leadership.

#### Continuous Enrollment

Doctoral students must maintain continuous enrollment, beginning the semester, inclusive of summer, after the doctoral core coursework ends. Students must maintain continuous enrollment at a minimum of one semester hour of research (ELAD 880V) or dissertation (ELAD 889V) credit during each regular semester, including at least one summer term each year, until the dissertation has been accepted by the Graduate Program. Students completing the dissertation with less than the specified 12-hour credit requirement should enroll in ELAD 889V to complete the twelve hour requirement during the graduation semester. This enrollment process is done through the CEE office.
