Formative Evaluations for Teacher Interns (2 for each 8-week placement and 4 for a 16-week placement) and Summative Evaluation (1 for each placement): The intern's work should be evaluated using evidence-based instructional practices using the formative evaluation forms. The rating of the intern should be communicated by both you and the clinical supervisor to facilitate growth and development. The summative evaluation will then be completed collaboratively by you and the clinical supervisor, and must be shared with the teacher intern.

- Feedback must be actionable, should build upon previous feedback, and linked to student learning.
- Include a copy of the Post-Conference forms in your evaluation packet
