The Becker CPA review costs are going up. Under the revised agreement, the year 1 costs with remain \$2,572 including tax. After year 1, fees will increase after the conclusion of each contract year by the greater of \$4, or CPI. The current bulletin provides for a \$2,600 special course fee. To accommodate the fee increase, the special course fee should be raised to \$3,000. Also, one of the prerequisites, ACCT 3033, mentioned in the bulletin for this course doesn't exist.
