The goal of this course is to provide veterinary students the knowledge they will need in clinical rotations and in the practice environment. Common domestic species will be covered including canine, feline, equine, bovine, small ruminant, camelid, and porcine.

- a. Describe and compare the normal physiology of reproduction in all domestic species including: follicular physiology, luteinization, luteolysis, and cyclicity.
- b. Describe the principles of management and manipulation of the reproductive cycle in domestic animal species.
- c. Describe uses of the common pharmaceuticals used in reproduction.
- d. Describe pertinent pregnancy testing methods across species.
- e. Describe basic Breeding Soundness Evaluation (BSE) procedures for male and female domestic species.
- f. Explain pathophysiology and develop a diagnosis, differential diagnosis, treatment, and prognosis for various reproductive diseases of domestic species including, but not limited to the following:

i.Infertility

ii.Peri-parturient diseases

iii.Abortion

iv.Dvstocia

v.Toxicities

vi.Herd Health

- g. Evaluate and describe interventions for various breeding management schemes for domestic species.
- h. Describe the techniques of artificial insemination and semen cryopreservation in selected domestic species.
- i. Recognize/Identify reproductive instrumentation covered in lecture or lab.

The course outcomes described above will be measured by direct means such as written exams and rubrics (assessing papers, presentations, oral exams, etc.) Final measurement instruments will be determined by course faculty.
