Lincoln Memorial University is a private nonprofit liberal arts university established near Cumberland Gap TN in 1897. It recently began establishing professional and biomedical colleges and the College of Veterinary Medicine was the most recent addition.

Dean Hoffsis joined the University soon after the CVM was envisioned and became the founding dean. He was charged with visioning and implementing the curriculum, facilities, gaining accreditation, and attracting a faculty. The CVM was successfully established and gained full accreditation in a very short period of time.

#### During Dean Hoffsis' Term:

- Full accreditation by AVMA Council on Education was achieved.
- Approximately 100,000 sq. ft. of teaching space was constructed.
- Approximately 30 resident faculty plus another 35 nonresident faculty and an equal number of staff have been employed.
- An affiliation agreement was established between LMU and University of Kentucky Gluck Equine Research Center and the Diagnostic Laboratory.
- A distributive model of clinical education was implemented with a network of approximately 200 practices.
- Three classes of over 100 veterinary students were successfully recruited from an applicant pool of over 1,000 applicants.

- Initiated and completed a new small animal hospital. This is a \$57 Million, 100,000 SF state-of-the-art referral hospital with exceptional design and equipment.
