The MSW program has been approved to go 100% online. This course is being added to accommodate the change from the 15-week semester to the 7-week semester for the foundation field sequence. Previously, students in the foundation year of the MSW program completed their internship hours over the fall and spring semesters with Foundation Field 1 and Foundation Field II with a total of 6 credit hours. This course will be added to the foundation field sequence as Foundation Field III, and all three courses will be 2 credit hours each, totaling the 6 credit hours required by the program for foundation field practice. (Course modification forms for Foundation Field I and Foundation Field II have been submitted to reduce credit hours from 3 to 2 per course)

This course supports the ability for the MSW program to go online by allowing adequate time for students to complete their foundation field internship hours. These competencies are set by our accrediting body, the Council on Social Work Education, and provide specific practice behaviors that align with the generalist skills needed by social workers. Students develop a learning agreement with their agency field supervisors that provides specific learning activities to integrate classroom knowledge into direct practice. This learning agreement is monitored and adjusted throughout the internship by the agency field supervisor, and faculty liaison to promote competency attainment and preparation for the advanced clinical year.
