April 14<sup>th</sup> Meeting Minutes: Lambertus motioned to approve, Hux seconded, all approved.

New Business

Introduction to Section IV Review

- Committee agreed to vote on Introduction edits after reviewing the edits presented last meeting.
- Committee continued discussion of Introduction, changes made in Summer Working Group and suggested edits by Melescue.
- Nothing is being removed, as all content is contained later parts in Section. Committee discusses highlighting these sections IV.D and IV.E in the Introduction language
- To include all current language, committee discusses linking directly to Title IX website in Section IV of Handbook. Additionally, IV.D and IV.E will be sent to Title IX website for approval.
- Gipson moves that the committee accepts the edits to the Introduction with the addition of the IV.D and IV.E language, Washam seconds, all approved.
- I. Section IV.A: Discuss edits indicated in copy from legal Also change first sentence, "Faculty grievance alleging institutional error applies only..." Approve edits.
  - Committee discusses changing language for clarity and correctness of the 1<sup>st</sup> sentence.
  - Gipson motions to accept that committee change the first sentence of section to read: "Faculty grievance alleging institutional error(s) applies only to terms and conditions of that faculty member's employment." Second sentence would begin "This includes..." Lambertus seconds, all approved.
  - Gipson motion to approve the inclusion of the discrimination statement at the end of second sentence, Washam seconds, all approved.
  - Lambertus moves to approve the edits of the rest of the paragraph made by summer working group and legal, Gipson seconds, all approve.
  - Committee discusses summer working and legal edits to second paragraph.
  - Gipson proposes that small edits accepted from summer working group and legal, Hux seconded, all approved. Including editing the title of "Associate Vice Chancellor of Human Resources" to "Assistant..."
- II. Section IV.B.1: Approve edits indicated in copy from legal
- Committee discusses editorial changes made by summer working group and legal.
- Committee agrees to include section when sending to Bush in Title IX.
- Legal made comment in section to delete part of sentence: "Faculty selected will..." in order to avoid discrimination and information does not appear in Book of Committees
- Lambertus moves to accept legal edits in IV.B.1.a, Hux seconds, all approve.

• Gipson moves to accept editorial edits in section, Washam seconds, all approve.
