- Danny Kopp from the History Department stated he would do the job if there were no others who were interested or had the time. Since no other council member was interested, DiDi appointed Danny Kopp the interim treasurer until the next election.
- John Franks inquired about the stipend for the officers. Tom provided the following information to the council.

The current stipends were:

President, \$0

Vice President \$1600

Secretary \$700

Treasurer \$400

Communications Chair \$400

Considerable discussion ensued concerning the president's stipend, the summer terms and the office GA positions. The president is now required, as of fall 2011, to be one of the GSC GA's due to the hours it takes to maintain the office and attend all required meetings. It was brought to the attention of the council that the current president established and maintained the GSC office during the summer of 2011 without any compensation and has asked for none.

- John Franks moved that the president be awarded a \$2500 stipend to allow the president to maintain the office during the summer and Interim periods, and that this stipend be retroactive to compensate the current president for maintaining the office during summer and fall 2011. Danny Kopp seconded the motion.
- The floor was opened for discussion. It was asked if there was a need to maintain the office during the summer. DiDi stated that she assisted many students both grad and undergrads that were coming on campus asking questions about the upcoming fall term. She also had to obtain many map brochures to help new and potential students with directions. DiDi further explained that many forms, such as guidelines, applications, etc. were needed to be developed during this past summer as well as coordinate with the Graduate School for the fall new graduate student orientation. DiDi stated that in her opinion it was very important that the office remain open
