Accelerated Masters Program

Undergraduate students seeking admission into the Accelerated Masters Program in Computer Science must meet the admission requirements of the Graduate School. In addition, applicants will be evaluated by the department for academic qualification based upon the following requirements:

- 1. minimum overall GPA of 3.00
- 2. minimum GPA of 3.25 in CS courses (exclusive of CS 1013 and 1114)
- 3. completion of CS 3113

Applicants not meeting all of the above departmental criteria may be admitted on a conditional basis if they meet the Graduate School admission requirements. After admission into the accelerated masters program, undergraduate students may take up to $\frac{12}{9}$ hours of

Satisfactory Progress

Students are required to maintain a "B" average in all graduate coursework in Computer Science and approved Mathematics/Statistics courses. If a student is placed on academic probation, they must increase the GPA to at least 3.0 within one semester or they will be removed from the program. A student who receives two "C"s in one semester or receives a "C" while on probation will be terminated from the program. A student who receives one "D" or one "F" will be removed from the program.

Minimum hours required for this program: 36 33

Department of History Graduate Faculty Qualification Standards

April 30, 2014

In addition to the criteria stipulated in the current ASU Faculty Handbook, the Department of History further defines the graduate faculty qualification standards for both the M.A. and M.S.E. programs:

A Regular Member of the Graduate Faculty must be a full-time faculty member with a terminal degree (Ph.D. or J.D.) in the Humanities or Social Sciences.

Regular Members must have documented evidence of an appropriate level of scholarly activity and continued participation in graduate education at the course, committee and program levels.

One of the following shall be sufficient evidence of an appropriate level of scholarly activity during a 6 year appointment as a member of the Graduate History Faculty:

- 1. Author of 1 peer reviewed publication by a scholarly press.
- 2. Editor or Co-Editor of a book published by a scholarly press.
- 3. Curation of 1 museum-quality public exhibit.
- 4. Author of 1 major public history report, i.e. application to the National (or Arkansas) Register of Historic Places, consultation report for historic preservation/interpretation project, or other report of comparable quality.
- 5. 1 funded research grant.
- 6. 1 year of service on an editorial board for a scholarly publication.
- 7. 3 professional presentations of research to recognized regional, state, national, or international scholarly entities other than Arkansas State University.
- 8. 3 published book reviews in a scholarly venue.
- 9. 3 manuscript reviews for either a scholarly press or journal.
- 10. A balanced combination of at least two of the components in #7 #9, i.e. 1 presentation of research, 2 published book reviews.

Appointment as a Regular Member of the Graduate Faculty shall be for a six year term. Reappointment shall adhere to current guidelines employed by the Graduate School or stipulated in the Faculty Handbook.
