- I. April 23, 2018 meeting minutes Shelley Gibson motioned to approve the minutes, and Dr. Philhours seconded. All Approved.

- V. Review of 2017-18 AAC Goals Most of the goals were achieved. We did not start the external surveys search for comparative data.
- VI. 2018-19 AAC Goals See slideshow attached. The committee reviewed the University Learning Outcomes.
- VII. Leaving the Den August Pilot—Dr. Wayne Wilkinson, Faculty Fellow for the AAC and Elizabeth Wakefield, Assessment Office Research Analyst
 - a. Deployment The committee discussed the deployment methods used and possible deployment options for the future.
 - b. Survey versions There were two separate pilots sent out. One for AOS Graduate level students, and one that included AOS undergraduate, and all on-campus students. The data that the committee focused on for this meeting was the data that included AOS undergraduate and all on-campus students.
 - c. Return-rate analysis The committee viewed return rates on a per college basis, and as a whole for demographics of which students responded versus which students did not. The committee discussed what a good return rate should look like. The pilot did have a good representation of each student demographic.
 - d. Content/response analysis The committee then reviewed the content from the data from the actual survey to show as being significantly different from the average on the point scale. Most areas were significantly higher, there were some that were not significantly different,

but still average and only a couple that were significantly lower. Because this is a pilot, there were no suggested actions to come out of the data, but several points of process improvement to collect data from the fall and spring graduates. The committee discussed that these students are reporting on things from as far back as four to five years ago, and many of the departments have been making improvements to their programs since that time. The committee is interested to see how these responses change over time.


e. The committee decided to meet again in two weeks after everyone has had time to digest the data and think about the process to discuss how to move forward and what changes should be made.

What is the AAC?

- Reviewing the university learning outcomes and recommending revisions when needed
- Developing an assessment process for the university learning outcomes
- Recommending the development, acquisition, and use of student selfreported evaluations and other types of surveys/questionnaires as institutional assessment instruments
- Providing leadership for the development and implementation of campuswide institutional assessment procedures
- Establishing and monitoring the University's annual assessment calendar
- Evaluating the institutional assessment procedures and making recommendations to the University's executive leadership (Chancellor, Provost, VC Student Affairs, VC Finance, etc.)
- Recommending the types of information that can be routinely communicated campus-wide and to the external constituencies/stakeholders and the appropriate channels for communicating this information
- Coordinating all assessment committees on campus—the Program-level Assessment Committee, General Education Committee, and Co-Curricular Assessment Committee
- Utilizing the A-State shared governance oversight process when appropriate for issues related to campus-wide assessment issues and/or procedures

AAC Goals 2017-18

- Finalize A-State Assessment Handbook
 - Status: Approved through shared governance and chancellor in May 2018
- Align ULOs with PLOs
 - Status: Completed
- Revise the Senior Exit Survey
 - Status: Renamed "Leaving the Den" and pilot conducted in August 2018
- Investigate using external surveys, such as NESSE, CIRP, etc.
 - Status: Not started
- Finalize University assessment plan
 - Status: In the midst
- Write initial assessment report
 - Status: Not started
- Develop communication plan for University assessment reports
 - Status: Explored but not developed; more to come today
