A-State Assessment Committee: Dr. Paul Mixon gave the update of the University Learning Outcomes (ULOs) process. ULOs were selected at the recent fruitful AAC meeting and are to be submitted for Shared Governance approval. Subgroups across campus were surveyed for choices of ULOs and the Top 4 were selected. Included in the subgroups were 35 undergraduate students and 20 graduate students who participated in the surveys. Best practice is to have 2-5 ULOs. Not all of the ULO's need to be assessed by each areathey can be aligned with 1 or more.
