PROFESSIONAL EXPERIENCE

7/12- Present **President**, Dillard University (New Orleans, LA)

Chief executive officer of the University with responsibility for all programs and operations, reporting to the Board of Trustees. Dillard University is a national liberal arts institution, member of the United Negro College Fund (UNCF) and affiliated with the United Methodist Church and the United Church of Christ. The University educates approximately 1,215 students from over 25 states and abroad, with 75% of the students receiving Pell Grants. The University has an operating budget of \$36 million and an endowment of \$108 million, with over 300 full and part time employees.

Major Accomplishments (Team)

- With the presidents of 3 additional HBCUs, secured loan forgiveness in March of 2018 from the Federal Government received due to the damage of Hurricane Katrina. For Dillard, the loan forgiven was for \$156 million. This followed the negotiation of a five year loan forbearance in 2013.
- Renegotiated property insurance, from \$1.8 million to just under \$1 million per year.
- Raised academic profile of freshman class, increased average ACT 15% and average HSGPA by 17%.
- Alumni giving increased from 4% in 2011-12 to 23% for 2017-18, and 2018-19.
- Implemented Giving Tuesday campaigns in 2016, raising \$64,000 the first year, to raising over \$800,000 in 2020.
- Completed post-Katrina renovations and completely opened all campus facilities by January, 2014.
- Secured historic tax credits for several renovated facilities (\$4M +).
- Secured largest single private gift (\$5M in 2020), and largest single alumni gift (\$5M in 2021).
- Completed successful SACSCOC reaffirmation in 2020.
- Through strong investment work and gifts, grew endowment from \$48.8M (June 2012) to

\$108M (September 2021).

- College of Business received Accreditation Council of Business Schools and Programs (ACBSP) accreditation in 2019, first time in university history.
