What is it?

"Eliminating Abusive and Rampant Neglect of Interactive Technologies", originally proposed in 2020, this act was intended to combat the spread of child sexual abuse material online by holding companies responsible for the sharing of this type of material on their platforms. This means that any sharing of explicit material containing children can and would be punished by extensive legal recourse, whether or not the company actually had any knowledge of said material.

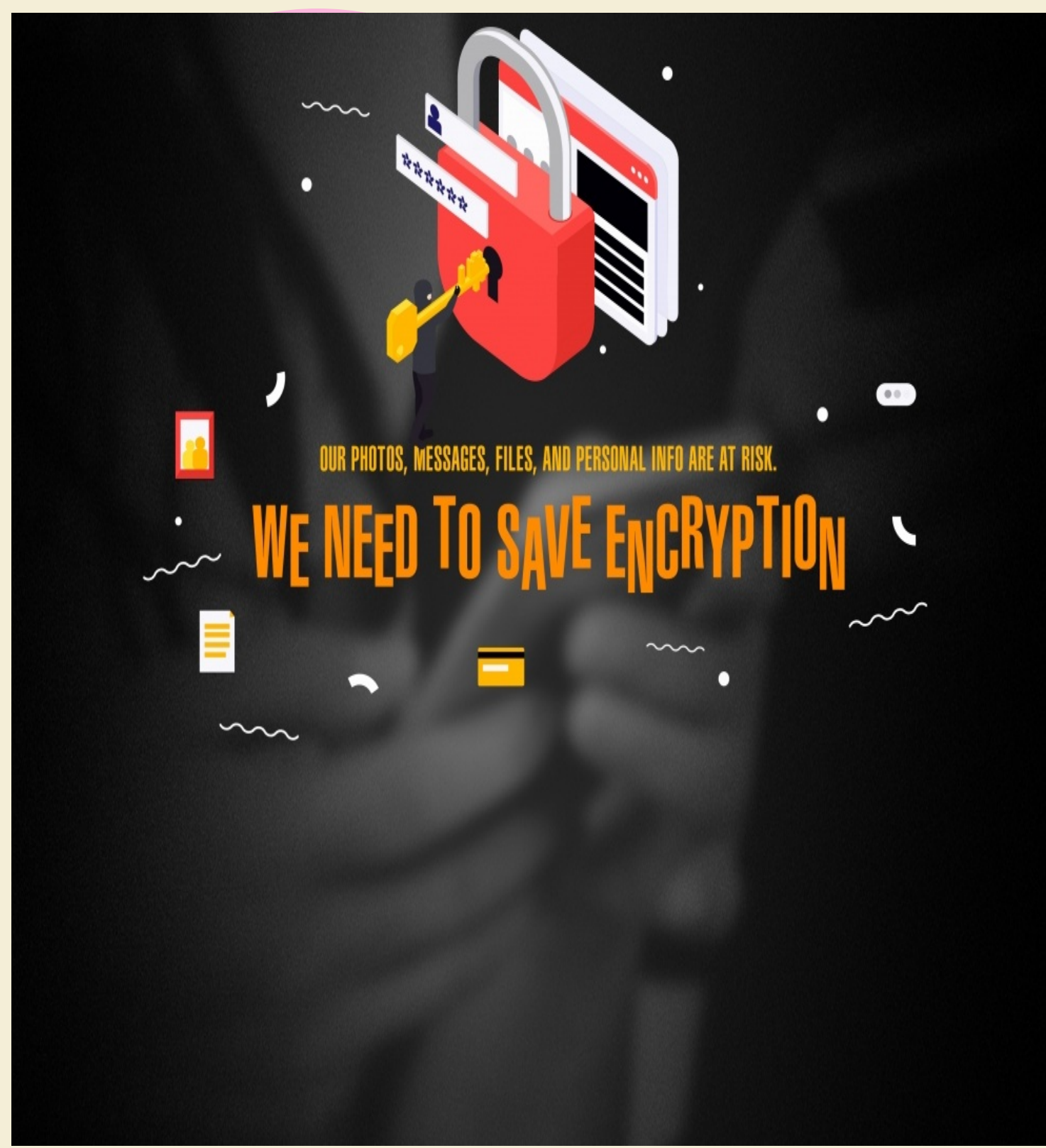
The Real Consequences
