CALL TO ORDER

The meeting was called to order at approximately 3:00pm by past chair Rutherford.

APPROVAL OF THE MINUTES

Past Chair Rutherford called for any corrections or additions to the minutes of September 15, 2000. No corrections or additions were distributed other than the misspelling of The Herald as notified by email.

REMARKS & DISCUSSION

Jill Simons, Coordinator of Advisement Services, reported on the creation of Advisement Services and its role on campus. Her position and Advisement Services were recommendations from the Retention Task Force. The purpose of Advisement Services at this time is to create a centralization of undecided advising, become a clearing house of services for advising, to supply a place for students to receive answers to simple advising questions, to do outreach to support faculty in their advising needs. As far as the future of advising on campus the model that looks to best serve our campus is a split model. One conceptualization of this model might be, that there would be an advising center where undecided advising may be housed, where some departments and colleges may want their freshman and sophomores advised, and then to have also departmental or college advising done by faculty as it is done now. Ms. Simons role at this time is to

involve faculty, departments and colleges to best determine what course advising will take on our campus. Ms. Simons is also acting as a support person for the Freshman Year Experience classes and is directing the new program Restart at State. A program for students who have been on academic suspension.

REPORTS

Past Chair Rutherford reported from Chair Bailey that he had inquired about the status of the investigation of the theft of The Herald three years ago . President Wyatt has requested information from Chief Ken Cooper of the University Police. There has been no report as of yet.

NEW BUSINESS

Senator Guffey ask for senators to inquire in their areas as to the interest of the faculty to having the campus pharmacy serve the faculty and staff as well as students. It was suggested that the chair of the Human Resources committee be ask to come and report to the senate on what his committee's findings are concerning the pharmacy.

Senator Guffey also encouraged the senate to promote having the half time director's position of the UTLC to become a full time position. This would help aid the creation and organization of the program.
